- Say normal Examination fee is. 1,550/-. Last date of receipt of examination form with additional late fee is say 30/05/2015. The examination form fee shall be 2,000/-(with additional late fee). If, as per Hou'ble Court order the examination form of any student is accepted say on 10/06/2015 (i.e. after 10 days from the last day of additional late fee.) Then the examination fee in this case shall be charged viz. 2,000/- + 3,000/- (300/- x 10 days) = 5,000/-.
- 2. Say normal Examination fee is. 1,550/-. Last date of receipt of examination form with additional late fee is say 29/03/2015. The examination form fee shall be 2,000/-(with additional late fee). If, as per Hon'ble Court order the examination form of any student is accepted say on 02/05/2015 (i.e. after 35 days from the last day of additional late fee.) Then the examination fee in this case shall be viz. 2,000/- + 10,500/- (300/- x 35 days) = 12,500/-. However, there is limit of 10,000/- actual fee shall be charged as 2,000/- + 10,000/- = 12,000/-
